

Teammate Basketball/NTBA Winter Nationals Waiver and Release

READ BEFORE SIGNING

IN CONSIDERATION OF attending The Winter National Championship as a spectator or IN CONSIDERATION OF my child/ward (minor), being allowed to participate in any way in Teammate Basketball, LLC ("TM") and National Travel Basketball, LLC ("NTBA") related events and activities, the undersigned acknowledges, appreciates, and agrees that:

PLAYER ACKNOWLEDGMENT:

The risk of injury to my child from the activities involved in these programs is significant, including the potential for permanent disability and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

- FOR MYSELF, SPOUSE, AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES or others, and assume full responsibility for my child's participation; and,
- 2. I willingly agree to comply with the program's stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the program itself, I will remove my child from the participation and bring such attention of the nearest official immediately; and,
- 3. I myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS TM and NTBA, it's directors, officers, officials, agents, employees, volunteers, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my child's involvement or participation in these programs, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
- 4. I, for myself, my spouse, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY INDEMNIFY AND HOLD HARMLESS all the above Releasees from any and all liabilities incident to my involvement or participation in these programs, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.

SPECTATOR AND PLAYER ACKNOWLEDGMENT:

By attending this event, you acknowledge your understanding of the contagious nature of COVID-19 and voluntarily assume the risk that you and/or your child(ren) could be exposed to or infected by COVID-19 while attending and/or playing in this event, and that such exposure or infection could result in illness or death. TM and NTBA has put in place preventative measures to reduce the spread of COVID-19; however, a risk of exposure to COVID-19 may exist in any place where people are present.

TM and NTBA, nor its suppliers or vendors, or the facility can guarantee that you will not be exposed to COVID-19 or other contagions during the event. As such, you voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any illness or death experienced in connection with the event. You hereby release covenant not to sue, discharge, and hold harmless TM and NTBA, and its event related staff, from any claims including all liabilities or expenses of any kind arising out of or relating thereto.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

I understand the seriousness of the risks involved in participating in this program, my personal responsibilities for adhering to rules and regulation, and accept them as a participant and/or spectator.
